All vendors are responsible for their own booths/tents/chairs/weights for canopies. Vendor set-up is 9:00am – 12:45pm day of the event. Teardown begins at 7:00pm. Vendors will maintain the space in a clean & sanitary condition, dispose of all waste in dumpsters provided. Reserved parking will be provided for 1 car or (truck-trailer) per vendor. Up to 4 workers admitted per booth. More than 4 workers will be charged \$15.00 per person. Names of each worker must be submitted prior to July 25, 2024.

Vendors agree to allow sampling of their products to individuals with designated wristbands. The designated wristbands are provided to individuals that have been pre-screened to meet age requirements. Vendors will not allow sampling or purchasing of their products to anyone without the designated wristband. Vendors will not pour full glasses of their product unless purchased from Vendor.

Vendor must provide proof of Commercial General Liability Insurance for limits of not less than the following: \$1,000,000 each occurrence limit (Bodily Injury & Property Damage) \$500,00 damage to rented premises \$5,000 med exp \$1,000,000 personal & advertising injury limit \$2,000,000 general aggregate per project \$2,000,000 products, Completed operations aggregate \$1,000,000 Liquor liability. Certificate of Insurance must be received prior to 8/6/23.

All applications and fees must be received by July 1, 2024; *however, available vendor's spaces are first come first serve.* All vendors are responsible for filing sales tax with the Baltimore County Comptroller's office. If you need a temporary license the comptroller will provide you a free 30 day license. Eastern Yacht Club is required to submit to the Comptroller's Office a list of all vendors attending the festival 10 days prior to the event. Vendor is responsible to pay any fines/ penalties levied due to non-compliance with Federal, Maryland State, or Baltimore County. Cancellation clause: *No refund after July 25, 2024.*

Terms: The undersigned agrees to assume the risk of loss to any property of my staff and myself for the loss or theft, breakage, or damage for the duration of the event. Further, I agree to indemnify and hold Eastern Yacht Club harmless from any and all claims, actions, damages, liability, and expense, including attorney fees in connection of loss of life, personal injury and/or damage to property that may be done or suffered by reason of my fault or negligence in the performance of or failure to perform my responsibilities.
